*Following an in-depth examination by the Managing Authority on the legal status of the project's lead partner falling within the SO 2.2, the Executive Committee approves the administrative compliance grid of JOB MATCH project which is part of this minutes. The Executive Committee requires to the MA to notify it to the lead partner.*

*The meeting moved on to **agenda item 7 – Any other business** where the following issue is inserted "Eligibility for further evaluation of MEDNETS project proposal". Following the appeal (ref. 2508 of 2017) proposed by Ass.For.Seo Società Consortile A.R.L., the Tribunale Amministrativo Regionale per la Sicilia (Sezione Prima) on the 23<sup>rd</sup> of November 2017 ordered "its eligibility for further step of the procedure" and "the settlement of the merit treatment of the appeal on 22 November 2018". Thus, the Executive Committee takes note that the project is "eligible for further evaluation".*

**Francesca Angori** refers about the opportunity to speed up the procedures to select the 4<sup>th</sup> member of the Joint Secretariat due to the huge work up to the current members of the Joint Secretariat. On this regards, Mrs Angori reminds that the JS has immediately to ensure both the launch of the approved projects (through the supporting activities to beneficiaries to sign the contracts, to train on the management, monitoring and claiming) and the launch of a new call for proposals for the allocation of the savings failed within the Public Notice 01/2016.

**The Joint Secretariat** highlights the opportunity to launch "targeted calls" able to ensure the submission of relevant projects able to better adhere to the needs of the programme's results and outputs indicators. The Joint Secretariat also highlights the need to revise the selection criteria in line with a targeted call and to foresee external evaluators. What above could ensure more adequate instruments to the procedure compatibly with the available human resources.
