Section C.9 of the AF reports per each procurement the procedures to be followed, namely the reference to LN352 of 2016 or equivalent for Maltese beneficiaries and DLG n. 50/2016 for Italian beneficiaries</p> <p>2. It is clarified that the PFS system will be developed jointly by P2 and P6 and tested by P4. The photocatalytic filter, the heart of the PFS unit, will be manufactured by P6. The PFS unit, consisting of tanks, pump, filter and other will be designed jointly by P1, P2, P6 and P5. The 10 PFS units will then be manufactured by P5. Five of these units will be installed at Maltese enterprises by P5 and five will be installed in Sicilian enterprises by P6</p> <p>3. Having regards project budget revision:</p> <ul style="list-style-type: none"> a) <u>Having regards to WP2</u> no budget reduction was provided. The LP refers that the whole budget as previously indicated is necessary to deliver the deliverables pertaining to WP2 considering that excluding academics and researchers is likely to render delivery very difficult, if not impossible. Moreover, the LP refers that budget allocated for PP2, PP3 and PP4 cannot be reduced considering that these partners have similar responsibilities as the LP, even if of varying levels, which is in fact reflected by the difference in budgets allocated b) <u>Having regards to WP6</u>, no budget reduction was provided but a transformation of such type of service from "vouchers" to "external consultant". The LP clarifies that technical advice will be given to 40 SMEs (20 in Malta and 20 in Sicily) coming from various industrial sectors. The UM and CNR shall each manage a sum of €10,000 which they will each use to engage a consultant. These consultants will provide technical advice, assisting the companies, selected via a call, to reduce water consumption through more effective use and/or reclamation methods. The two consultants shall have the responsibility to inspect the clients' premises,

			c) acquire the necessary information, prepare a technical report highlighting options how water can be saved, and provide an estimate of the recommended changes d) Having regards to "travel and accommodation" reductions have been applied up to a maximum of 4% of the entire project budget and not 3%. The LP refers that only the expenses related to "Steering committee meeting" and "Conferences" could be reduced without affecting the achievement of project outputs and results mainly dedicated to cross border technology transfer in a number of KETs involving a total of 60 persons. Thus a reduction of € 36.198,00 was applied by on the line item "travel and accommodation". This change led to a reduction in the staff costs of € 4.819 up to the LP and PP3 needed to maintain the latter within the specified 40% limit and related administrative cost of € 481,90 5. Furthermore, the LP modifies the value of output 6.3, namely Table B reports the value of 2 and WP6 reports the value of 4</p> <p>2. Having regards project budget revision:</p> <ul style="list-style-type: none"> a) <u>Having regards to WP0</u> The total amount requested has been brought in line with programme requirements and now stands at €19.000. For what above, the '<u>additional co-financing</u>' from UNIPA for WP0 of €2.400 has been removed. (this modification afflicts the evaluation grid) b) <u>Having regards to WP1</u> costs have now been brought in line with 20% of total admissible costs and correspond to € 490.809,10, namely € 74.450,60 less than the original budget. However, in order to provide such cuts, the LP-UNIPA reduced part of its '<u>additional co-financing</u>' for the amount of € 21.600, PP2-Comune di Lipari reduced part of its '<u>additional co-financing</u>' for the amount of € 24.000. (this modification afflicts the evaluation grid) c) <u>Having regards to WP2</u>, PP3 reduced costs for kick off and final meetings of € 28.000 d) <u>Having regards to WP2</u>, PP3 reduced costs for "Communications, press office, printing services" of € 30.000 e) <u>Having regards to WP2</u>, PP3 reduced costs for "Communications responsible person and stakeholder strategist" of € 30.000 f) <u>Having regards to WP3</u>, LP clarifies that the number 10 does not refer to the number of people going to Lipari but the number of trips to be made by researchers within the 6-month period. 		<p>month in order to transfer expertise and follow the lab activities and work being carried out by the lab technician on the island. The LP reduced the costs per visit to €300 from €500. Such reduction is supported by accompanying documents which indicates the fares applied by ferries. For what above a reduction of € 12.000 was applied.</p> <p>g) <u>Having regards to State aid issue</u> the LP refers that ABT have agreed to accept a reduction in the intensity of the contribution as required by the Executive Committee comments. However, two adjustments have been made in this regard.</p> <ul style="list-style-type: none"> - ABT will no longer buy the fishmeal mill (€28,000) as it does not enter into their core business activities. This will now be bought by UNIPA and housed on Lipari for the duration of the project. The fishmeal from the Lipari lab will produce flour for the fish feed development. The flour will be transported to Malta for the various steps of fish feed development - ABT will no longer manage the "contract for the Lab manager to coordinate work at the DFA lab plus support to stakeholder strategy in Malta" within WP3 as "external expertise and services". The LP refers that this is clearly a figure of crucial importance to the project's success. The contract will now be issued and managed by PP3. <u>It is highlighted that originally it was an activity scheduled within WP3 and the new version of the AF reports such activities in WP5 as "Site manager of the lab - Lipari, Sicily and local business expert" as "staff costs". It is also highlighted that the corresponding "travel and accommodation costs" were brought to PP3 too. However, the estimated costs for "travel and accommodation" were originally amounting to € 3.200 but in the new version of the AF such costs amount to € 18.000 in WP5. No details were provided within the AF (word section) regarding such type of modifications.</u> <p>h) <u>Having regards to VAT issue</u> the LP refers that in accordance with par. 9.6.1 of the manual of Interreg Italia Malta programme, all prices are recorded in the budget excel as VAT exclusive</p> <p>4.
