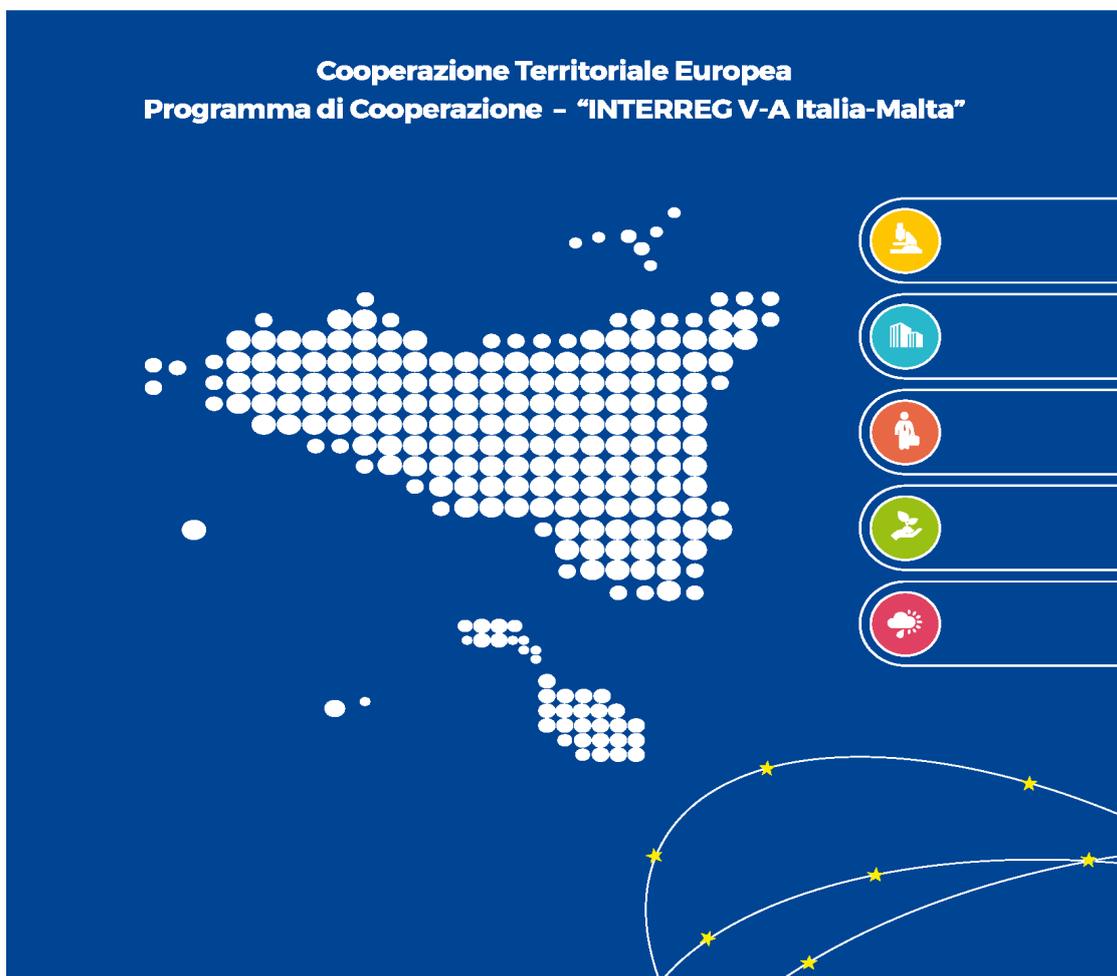

2. OVERVIEW OF THE IMPLEMENTATION OF THE COOPERATION PROGRAMME (Article 50(2) of Regulation (EU) No 1303/2013 and Article 14(3)(a) of Regulation (EU) No 1299/2013)

Key information on the implementation of the cooperation programme for the year concerned, including on financial -- instruments, with relation to the financial and indicator data.

In 2019, the action of the Managing Authority and the Malta National Coordination Authority with the support of the Joint Secretariat supported the implementation of the program's axes. In particular:

- Implementation of projects funded under Public Notice 01/2016
- Support actions for sound implementation, management, monitoring and surveillance of the program

Projects implementation financed under the Public Notice 01/2016 during the year 2019 , there has been an overall progress of the program output indicators of which is provided below an overview classified by priority axis and indicator.

Axis I – Indicator CO01

The NATIFLIFE project aimed at developing assistive technology to facilitate the de-hospitalisation of elderly people in nursing homes. To date, the project has created a network of 13 associated companies that exchange *peer-to-peer* products-services-information so to reduce costs for health care system.

Axis I – Indicators CO04

The BYTHOS project, which aims to develop sustainable resources from fish and catering industry waste in Sicily and Malta, has so far involved 6 companies that use laboratory services to reduce waste disposal risks.

The MEDIWARN project aimed to develop a monitoring system for the real-time acquisition of patients' vital parameters through the use of a peripheral sensory system equipped with artificial intelligence. To date the project has involved 2 companies for actions aimed at industrial prototyping and the commercialization of technological products derived.

The NATIFLIFE project has also identified 10 companies that will benefit from the transfer of

knowledge on new methodologies and technologies for the development of assistive home automation.

Axis II – Indicators CO01, CO03 and 2.1.3

The ENISIE project, aimed to create and strengthen companies in the area of social enterprise and social responsibility sectors. The project involved 11 companies in Malta and Sicily, that benefited from experimental services for the growth of social innovation and social business. The project also experimented with innovative services for access to credit and micro-finance in Malta and Sicily involving No. 2 companies and has developed No. 1 service network consisting of an open *source* cross-border platform for the digitization of support services between Malta and Sicily..

Axis II – Indicators 2.2.1 and 2.2.2

The JOB MATCH 2020 project aimed to create a cooperation centre to promote harmonization of *recruitment* processes, the mobility of workers and their qualifications. The project has set up a portal for the provision of counselling, tutoring, recruiting, human resources management services for the two countries and thus supporting the matchmaking of work demand and supply. The project also involved 10 Italian and Maltese companies in activities to exchange experiences through internships.

Axis III – Indicators 3.1.1 and 3.1.3

The HARMONY project aimed to implement integrated measures to monitor and control the integrity of the seabed and the species that inhabit them and to develop measures to manage Natura 2000 marine sites and habitats, through a network of subjects involved in the data collection through *Local Ecological Knowledge*. It has created an *inventory* of cross-border biodiversity in sites and Habitat Natura 2000. The project also carried out an awareness campaign to make sure the fruition of protected areas through interviews\meetings with institutional actors aimed at the transfer of project guidelines (e.g. focus groups).

Axis III – Indicator 3.2.1

The BESS project aimed to of a management system for environmental niches - pocket beaches, that is small beaches limited by natural headlands that constitute a naturally resilient response to the effects of climate change. The project has created a surveillance system to cover an area of 83.000.000 sqm of beaches.

The NEWS project, aimed at the implementation of an integrated system for monitoring risks coming from the sea and for early warning to the population about the possibility of risks while also activating safeguards to prevent harm to people. The project has created an area monitoring network to measure the characteristics of the waves covering a marine surface of 1.000.000.000 sqm.

From a financial point of view on the 31/12/2019 Axes I, II, III , recorded an absorption of ERDF resources certified to the EC of €4,640,585, of which €1,836,589 on Axis I for 6 operations; €737,244 on Axis II for 3 operations; €2,066,751 on Axis III for 6 operations.

With regard to support actions for sound implementation, management, monitoring and surveillance of the programme, during 2019, the action of the Managing Authority and the Malta National Coordinating Authority, supported by the Joint Secretariat, ensured the proper implementation of the programme and projects financed under The 01/2016 Notice, as well as the correct information and communication activities with regard to potential beneficiaries of the 02/2019 Notice.

The activity took place both through constant and daily contact with beneficiaries for the resolution of contingent issues and through summits and meetings requested by beneficiaries or arranged by the MA/MNCA.

Referring specifically to the support for beneficiaries of the 01/2016 Notice, hereunder are described the details of the meetings\summits held in Sicily and Malta:

- 18 recurrent meetings\summits to support beneficiaries in the implementation of operations carried out in Sicily. In particular, these concerned the compliance with the execution times of the activities provided in the AF for the achievement of the output and result indicators; compliance with project GANTT chart; compliance with the PF indicators for the year 2018; details about public procedures concluded and to be implemented; how to fill in the RofR in order to comply with the needs of Ulysses and the program; how to do projects review and budget changes.
- An annual meeting has been conducted in Malta with all the 32 Maltese beneficiaries with the aim of documenting the developments and project implementation as planned in the AF, particularly the attainment of the project output indicators and targets, expenditure balance to be certified vis-à-vis the annual programme targets. The possible project modifications and other issues have also been discussed. In addition, the Malta National Coordinating Authority attends the project Steering Committees on a regular basis in view of its monitoring role.

In view of the Notice 02/2019, 6 information and communication activities for were held targeting potential beneficiaries in Sicily and Malta: 1) 17/06/2019 – Enna; 2) 18/06/2019 – Catania; 3) 18/06/2019 – Catania; 4) 24/06/2019 – Palermo; 5) 24/06/2019 – Palermo; 6) 4/7/2019 – Malta.

From a financial point of view, as at 31/12/2019, Axis IV recorded an absorption of EC-certified ERDF resources equal to €806,514 for 9 operations.

Overall, the Program implementation, management, monitoring and surveillance activities ensured the achievement of the expenditure target N+3; as at 31/12/2019a total of €5,447,100 ERDF claims have been submitted vis-à-vis the expenditure target of €4,085,374.

Axis IV	Technical support	<p>During 2019, the selection process of the Programme's Joint Secretariat fourth member selection was completed. As from the beginning of May 2019, this member was engaged and is acting as a (junior) programme assistant .</p> <p>With reference to the MA internal staff responsible for programme implementation, monitoring and surveillance, it is to be noted that several procedures for recruiting additional human resources as internal staff aimed at strengthening MA administrative capacity have been published. However, due to the regional administrative structure reshaping, these acts of appeal have not been successful and therefore new internal procedures are under way for the identification of internal staff to be employed on INTERREG V-A Italy Malta activities.</p> <p>Regarding monitoring activities, the Managing Authority initiated a procedure for setting up a long list of external experts to support the First Level Control unit. These external controllers will be employed in the first-level control activities related to Public Notice 02/2019. This is in order not to overwhelm the current internal controllers engaged in first-level control activities of the operations financed under the Public Notice 01/2016.</p>

4. SYNTHESIS OF THE EVALUATIONS (Article 50(2) of Regulation (EU) No 1303/2013)

The Program Evaluation Plan includes both **operational** assessments - regarding CP's implementation processes and the structures involved, the Program ability to achieve its specific objectives through the correct logical connection between actions and expected results and the

modalities and levels of use of available resources - and **strategic** assessments, inherent in the CP contribution towards achieving Europe 2020 strategy goal.

Following art. 114 of the Reg (EU) No. 1303/2013, the MA drew up the plan and, based on its contents, commissioned the Sicilian Region Public Investment Assessment and Verification Centre (NVVIP - Nucleo di Valutazione e Verifica degli Investimenti Pubblici), a technical structure to support the "*phases of planning, evaluation, implementation and verification of plans, programmes and intervention policies promoted and implemented by each individual administration*" (institutional law No. 144/1999), functionally placed within the Programming Department, to carry out the implementation evaluation.

More specifically, based on the planning path of the evaluation exercise contained within the document approved by the MC, the NVVIP carried out the implementation assessment (Part I), referring to the period between the start of the programme and May 2017, which has been reported in the Annual Implementation Report presented in 2018.

In 2019, the preparatory activities for the realisation of the implementation assessment (Part II) were launched. This Part II provides, on one hand, an update of the first report with reference to the aspects of the organisation and functionality of the structures responsible for implementing the programme as well as the adequacy of the procedures adopted for the selection of operations and, on the other, contains some assessments of programme ability to achieve the expected results by the 2023 annuity.

In particular, main aspects investigated in the implementation assessment (Part II) were as follows:

- Functionality of the program management structures and the degree of implementation of the same;
- Effectiveness/efficiency of the processes for submission and selection of applications, also in relation to the compliance of approved projects to the horizontal principles (Art. 7 and 8 of Reg. 1303/2013);
- Effectiveness, in terms of Program ability to achieve expected results with particular reference to Performance Framework targets and efficiency (the financial aspect of the CP);
- Level of integration of the Programme with the other instruments of the Union;
- Effectiveness of the management of the new cooperation area;
- Effectiveness of the Communication Strategy: a) communication and dissemination to the public; b) communication and information to beneficiaries

The realization of the second phase of the programme implementation assessment has been commissioned to Sicilian Region Public Investment Assessment and Verification Centre (NVVIP) and the results of this assessment will be made available during the 2020 financial year.

5. ISSUES AFFECTING THE PERFORMANCE OF THE PROGRAMME AND MEASURES TAKEN (article 50(2) of Regulation (EU) No 1303/2013)

a) Issues which affect the performance of the programme and the measures taken

With regard to aspects that affect programme results, it should be noted that during the year 2019, the program authorities continued to ensure the acceleration of all the main administrative procedures that had been initiated late and/or had shown slowdowns during the previous years of program implementation.

Specifically, in March 2019, the Program Executive Committee approved the new operation

implementation manual and selection criteria, for subsequent approval by the Monitoring Committee, in order to launch **the call No. 02/2019 "targeted call" for the presentation of cooperation projects with "one step" procedure to apply to Priority Axes I, II, III of the programme.**

On 04 April 2019, the Monitoring Committee, during Palermo meeting, approved all the documentation related to the call 02/2019, thus adopting all the corrective actions suggested by the Joint Secretariat to ensure the acceleration of the implementation processes.

Summarizing, these actions concerned:

- 1) **Re-modelling of the criteria for selecting operations** in order to ensure that the criteria is more coherent with public notice 02/2019. This has improved the readability of the selection criteria with regard to AF related sections;
- 2) **Pre-disposition of a public notice organized in 4 intervention schemes** for each SO covered by the Notice. Identification within each tab of the specific purposes of the project proposals with obligation for potential beneficiaries to include only a few output and result indicators. This was done to improve the better understanding of the specific call requests for each SO and, at the same time, ensure the submission of project proposals by potential beneficiaries, which closely adhere to the output indicators expected as program targets for 2023;
- 3) **Pre-disposition of AF No. 03 - excel section** with a control mechanism and information alerts which, in the case of financial instances , regulated in the public notice as reason for exclusion, shall alert the potential beneficiary with information on how to modify the erroneous sections in order to avoid the ineligibility of the proposal;
- 4) **Mandatory application of simplified cost (Flat rate cost)** for "office and administrative costs" (Art. 68 par 1 lett b Reg 1303/2013) and for the "staff costs"(Art. 19 Reg 1299/2013), with reference to the project proposals under SO 1.1 and 2.2 in order to contribute significantly to the reduction of administrative burdens for beneficiaries and to speed up the evaluation process on the AF financial section;
- 5) **Mandatory application of spending limits on work packages** provided by the project proposals in order to contribute significantly to the reduction of administrative burdens for beneficiaries and to speed up the evaluation process on the AF financial section.

The notice 02/2019 was published in Sicilian Region Official Journal "GURS" on 31/05/2019 and remained open until 09/08/2019.

The simplification of the measures introduced for the generation phase of operations, referred to in call 02/2019, allowed the Joint Secretariat to present the results to the Executive Committee, of the administrative eligibility exercise carried out on the project proposals submitted under Notice 02/2019, already on 07 October 2019.

The Program Executive Committee:

- On 22/10/2019, approved 18 Administrative compliance grids and simultaneously authorised the program MA to request document regularisation for 9 project proposals in order to ensure the widest participation in the selection procedure;
- On 18/11/2019, approved the regularisation of 09 project proposals and requested the MA to notify the results of the procedure.

The Program MA, after notifying all potential Lead Partners about the Executive Committee's investigation results, on 23/12/2019 launched a new written procedure among the Executive Committee members for the approval of the letters to be sent in reply to the counter-deductions submitted by three potential Lead Partners, against the decision to exclude them from the

eligibility procedure.

The summary of the administrative procedures, initiated and concluded during the year 2019, highlights the acceleration processes carried out in the programming and implementation procedures made by the programme authorities. In the course of 2019, therefore, the necessary corrective mechanisms were ensured in order to allow the programme to fully achieve the results.
