**Le Vie dei Tesori Foundation** is a partner of the EU-funded project “**Cultural Heritage fOR AIL: CHORAL**”.

The CHORAL project aims to improve green and digital accessibility to cultural heritage sites in Malta and Palermo. The goal is to enhance accessibility for both tourists and residents, developing a joint strategy and installing orientation totems to encourage more sustainable mobility. The project also plans the digitisation of less accessible sites, experimenting with tools in both regions. CHORAL promotes knowledge transfer, creates sustainable frameworks for digitisation, and enhances cultural heritage through increased access and value.

The partnership brings together an interdisciplinary team with diverse expertise, capable of effectively achieving project results and obtaining a significant impact. The project addresses the broader issues related to tourist accessibility to cultural heritage sites, identifying gaps in physical accessibility, experimenting with simple and low-cost infrastructures to encourage sustainable tourism, and developing a joint strategy to improve accessibility for all. Throughout the process, the project also selects hard-to-access sites to be digitised, thus extending the concept of accessibility and encouraging greater tourist engagement with cultural heritage and cultural venues.

The duration of the project is 24 months (start date: **02/01/2025** – end date: **02/01/2027**).

## **SCOPE**

This call for applications is aimed at the selection of the following professional roles:

- N°4 Expert for cultural heritage mapping;
- N° 1 Graphics manager;
- N° 2 Responsible for press communication;
- N° 1 Expert for the creation of the visual identity;
- N° 25 Responsible for disseminating information in cultural venues.

## **TASKS/RESPONSIBILITIES/ACTIVITIES EXPECTED FOR THE SELECTED ROLES.**

The selected individuals for the several roles will collaborate with the staff of Le Vie dei Tesori Foundation in achieving the objectives specific to their assigned role. The technical specifications of the assignment and the related compensation will be detailed during the interview scheduled after the submission of applications.

## **REQUIREMENTS FOR PARTICIPATION IN THE SELECTION PROCESS FOR THE VARIOUS ROLES**

1. High school diploma or equivalent qualification with at least three years of proven experience relevant to the position for which the application is submitted.
2. Excellent knowledge of the Italian language, written and spoken.
3. Excellent knowledge of the main online communication platforms (e.g., Zoom, Google Meet, etc.).
4. Excellent organizational skills, time management, teamwork, problem-solving.

Knowledge of the English language is a preferential skill.

The assignment will have a duration of 18 months, starting from the contract signing date.
