Workshop Communication

With the start of the 2021-2027 programming period comes the need for clarification of the new provisions for better visibility of the EU. This will also be the occasion to demonstrate that communication works and that building trust across borders places Interreg as a decisive element of EU Cohesion policy. During this workshop, we will discuss the implication along the programme life cycle and how to use communication and the tools available for inspiring outcomes.

Workshop Green Deal

Interreg has long been contributing to the protection of nature, preservation of biodiversity and the environment and will continue to do so. However, to achieve the ambitious goal of the EU Green Deal, there is also the need for innovative projects outside of the classic implementation repository to green the industry, businesses etc. The aim of the workshop is to shed light on the latter with inspiring examples.

Workshop Implementation

The objective is to improve the overall quality of financed and implemented projects. Thus, the workshop will focus on the selection of pertinent operations to be financed in the future by Interreg through the following steps of the project cycle: assessment, selection and decision-making.

Workshop Governance (ISO1 & 2)

The workshop will move from a general introduction about the "idea and origin" through specific understanding, examples and outlooks towards three specific dimensions: "DATA", "SERVICES" and "GOVERNANCE FOR ISO 2".
